STEP 1

Read the entire handbook and fill out the forms and online application responses. This is a huge commitment, talk with your local advisor, school administration, and if under 18, your guardians before making this decision.

State Advisor Tip: Write out your online responses using Word or a similar interface. This will help you formulate your responses, proofread, and get input from your support system.



STEP 2

After carefully proofreading your application and online responses, submit everything in one document using the online form. Double check everything before submitting so you do not forget something important.

State Advisor Tip: Submit a high quality, well lighted, recent photo of yourself, even if it is one taken on a phone at school. Dress professionally for it too!

In 2020 the officer applications photos were used on social media and the website.



STEP 3

After submitting your application, start practicing for the screening day. Practice makes perfect! Try doing a mock interview at school and answering questions that might be asked at screening.

State Advisor Tip: The more you practice with different groups of people, the less nervous you will be on screening day! Remember to introduce yourself!
